We are very fortunate to have Alex Beaton coming to PEI to offer a cross country jumping clinic JUNE 12<sup>th</sup> & 13<sup>th</sup> at Strathgartney Equestrian Park to all interested riders. NO PREVIOUS EVENTING EXPERIENCE IS NECESSARY. However, you and your horse or pony should be comfortable jumping cross rails, and confident riding in an open field. Due to having a high number of entries in previous years, we have booked Alex for Sunday June 12<sup>th</sup> as well. The first 16 participants will be scheduled on Saturday. Later entries will be scheduled to ride on Sunday. Riders who wish to ride both days CAN do so. Please make that clear on your entry. Of course each lesson will be a separate charge. If you do not have a horse to ride, come listen and learn, free of charge. Parents and spectators are encouraged to attend.

**Alex Beaton** resides in Wilmot, Nova Scotia. Alex has an extensive pony club and eventing background. She has achieved her "A" level of proficiency with the Canadian Pony Club. She has also competed at the intermediate level and was long listed for the Canadian 3-day eventing team in the late '80s. She is a level 1 coach.

**Clinic format:** Participants will receive a 1½ hour group lesson over cross country jumps. Alex will use the information provided on the application form to divide participants into groups of similar background and ability. Your group composition, and the time for you to be tacked up and ready to ride at Strathgartney will be available Thursday evening, June 10<sup>th</sup> from 6 to 10pm from Laura Dear at 902-566-4699

**Registration fee:** \$50.00 (\$60.00 for non-Horse-Trials members)

**Insurance policy:** All Competitors MUST provide proof of provincial insurance. Off-Island competitors must include photocopy of proof of \$2 million liability insurance with their entry form (a photocopy of NSEF or NBEA membership card is adequate.) TEMPORARY INSURANCE available on site, for \$15.00 per day.
